◆ **Hospice Physician Compliance Conference ... two sessions - Initial and Intensive ... April 17 ... October 2 (changed)**

These all-day events (*one for initial HMDC certifiants, and a more intensive training*) will provide the hospice physician with a comprehensive foundation of the Medicare Hospice Benefit and is essential for hospice physician leadership and engagement in hospice compliance. Applicable to all hospice physicians including those new to hospice, preparing for Initial HMDC Certification, or seasoned physicians who are looking to re-engage with their organization. The Initial course is specifically designed to catapult new hospice physicians into the complexities of hospice regulations while providing guidance on best practices to ensure compliance and payment. The Intensive is for seasoned hospice providers.

◆ **Drafting Comprehensive Physician Narratives ... two sessions ... May 15 or November 6**

An intensive course focused on documentation strategies specifically designed for the hospice physician. Course content includes clinical eligibility determinations, composing physician narrative statements, and wholly utilizing the physician's expertise to draft compelling documentation to support payment. The intensive sessions also address correct use of hospice assessment tools, and creating compelling and compliant documentation to ensure payment. This course has a documentation emphasis while integrating the basics of eligibility and compliance. If a hospice physician is struggling to draft strong physician narrative statements, this course is a great place to start!

◆ **Nurse Practitioner Documentation Clinic ... two sessions ... May 1 or October 9**

Focusing on enhancement of the Nurse Practitioner's clinical assessment and documentation of the Face-to-Face Encounter (F2FE), this one-day course delineates the roles of the nurse practitioner and the hospice physician. This course will include an in-depth review of disease trajectories, Local Coverage Determination (LCD) guidelines, and hospice assessment tools and how to include these elements in the F2FE documentation to assist the certifying physician in making a strong prognostication decision. This course is designed to share best practice documentation tips to ensure F2F documentation enhances the patient's clinical record and serves as a great tool for the recertifying physician.

◆ **The General Inpatient (GIP) Level of Care Intensive ... one session ... April 10**

Use of the General Inpatient (GIP) Level of Care is high on CMS' radar where hospices are evaluated on both the lack of provision or excessive provision of this higher level of care. This course will provide guidance on appropriate utilization, documentation and billing of GIP care, while also offering strategies for strengthening your hospice's GIP practice. Hospice medical directors, hospice physicians, nurse practitioners and hospice administration should not miss this intensive course designed to maximize hospice GIP compliance.

◆ **Hospice Audit Survival Training ... one session ... September 25**

Payment-related audits from CMS contractors pose the greatest financial risk to hospice providers today. However, many hospices remain ill-equipped to properly respond to these audits (e.g., Targeted Probe and Educate (TPE), Supplemental Medical Review Contractor (SMRC), or Unified Program Integrity Contractor (UPIC) audits, etc.) and mitigate payment-related denials during the Medicare appeals process. In this course, the teams from Weatherbee Resources and the Hospice Medical Director Certification Board (HMDCB) will take a deep dive into the most prevalent audits and share a step-by-step plan to ensure a timely and comprehensive response from initial clinical record submission to the provision of expert witness testimony at the Administrative Law Judge (ALJ) appeal level or beyond.

◆ **Hospice Regulatory Boot Camp ... three sessions ... March 30 - April 1 or August 10-12* or December 7-9**

A three-day deep dive into the regulatory requirements for technical and clinical eligibility and the Conditions of Participation and Conditions for Payment. Using three case studies, learn about documentation tips, Medical Director engagement, secondary conditions and co-morbidities; relatedness, compliant care plans and IDG meetings, and much more!
